1. CALL REGULAR MEETING TO ORDER -

President Westergard called the Regular meeting to order at 10:00 a.m.

2. PUBLIC COMMENT - None

3. APPROVE AGENDA –

Director Dennis made a motion to approve the Agenda as presented; seconded by Director Capurro; motion carried.

4. APPROVAL OF MINUTES AND CHECKS WRITTEN -

Director Capurro made a motion to approve the November 2016 Minutes and financial statements as submitted and checks written on Bank of America #9403 - #9408 and Nevada State Bank #2728 - #2736, motion seconded by Director Dennis; Director Dennis abstained as he was not present at the previous month's meeting; motion carried.

5. FEDERAL WATERMASTER'S REPORT - Chad Blanchard

SNOTEL report: Tahoe Basin 203%; Truckee River Basin 207%; Carson Basin 215%; Walker River Basin 221%; Upper Humboldt 150%; Lower Humboldt 131%. We are currently leading in both SNOTEL and precipitation numbers this year. Tahoe has thus far come up 3.8 feet, forecast is to easily fill Tahoe. Tahoe will have the biggest physical rise since 1907.

8. DISCUSSION AND POSSIBLE BOARD DIRECTION REGARDING THE MARTIS CREEK AGREEMENT & SUPERINTENDENT RESPONSIBILITIES – Ron Penrose/Lori Williams

Potential Notice language for the web page was given to the Board for review (copy of which is available at District Offices). There was discussion as to some of the language used.

Director Dennis made a motion to have the Notice as follow and that a link to said notice possible be added to other agency pertinent to the issue:

Public Notice: The Martis Creek Lake Project, including the reservoir and related channel improvements, DO NOT provide protection against all floods.

This notice is provided by the Carson Truckee Water Conservancy District, the local project sponsor, as a provision to the 1973 Martis Creek Lake Agreement with the U.S. Army Corp of Engineers.

Ms. Williams provided the Board with pictures of various areas of concern after the last flow event that she feels requires attention. Ms. Williams feels that the \$8,000 remaining in the budget for debris removal is not enough. Ms. Williams believes that \$25,000 would get the major snags out of the River.

❖ Director Capurro made a motion for Ms. Williams to spend up to \$25,000 using her discretion as far as which areas to clear; seconded by Director Dennis; motion carried.

Director Enloe does attend in his capacity at TMWA and could notify the District of any issues that did pertain to CTWCD. The Board felt that Superintendent Penrose would be the appropriate person to fill this position. Mr. Penrose left the meeting early and the Board felt he should be consulted prior to nomination, therefore this item would be discussed at the next meeting.
